Approved Roofing Materials as of AUGUST 2021

The table below lists the options of currently approved roofing replacement materials for Remington homes. As you plan your roof replacement project, please keep the following items in mind:

- **A project request form must be submitted for all roofing projects, regardless of materials selected.** Requests must include specific materials (manufacturer, product line and color) and are subject to the review timeline.
- Selecting one of the existing materials will simplify the approval process. However, homeowners may submit a color or material not listed, but must account for the additional time required for committee/board review.

Review Process for Unapproved Roofing Materials

Homeowners may submit a color or material not listed and the RHOA Board/ACC will review to determine its consistency with Association quality expectations. The goal is to ensure that any roof replacement has a “shake-like appearance”.

Key product attributes considered include:

- Appearance/Design. Shingle must be considered an architectural design class, not 3 tab.
- Mass. Weight must be a minimum of 355 per square (100 square feet) (17.3 kg/sq m).
- Color. Color tones cannot be outside a conservative range of tints fitting with the Remington character.

Please be prepared to present a product sample board (usually provided by the roofer), a project request form, and allow for up to 30 days for review. The Homeowner’s Association reserves the right to deny any roof material that does not meet the minimum quality.
